# OHS information for employers

This resource summarizes key rights of employers in relation to Alberta Occupational Health and Safety (OHS) regulatory compliance.

#### **KEY INFORMATION**

- Alberta employers have the right to:
  - Fair treatment and professionalism.
  - Confidentiality and privacy.
  - Appeal an OHS action.

# Right to fair treatment and professionalism

Alberta OHS staff must conduct themselves professionally as representatives of the Government of Alberta.

When an employer interacts with Alberta OHS they have a right to expect our officers to:

- Conduct their work with honesty and integrity by:
  - Following and applying policies and procedures.
  - Fully explaining the rationale behind a decision.
  - Fully explaining options and providing details of the inspection or investigation processes.
- Treat everyone with respect at all times.
- Perform all duties impartially, objectively, fairly and without discrimination, favours or ill will.
- Keep confidential information confidential unless performance of duties or legalities take precedence.
- Conduct activities in a responsive and timely fashion.

OHS officers are guided by the fundamentals of professionalism best practices outlined in <a href="Professionalism in the Workplace: Integrity in Enforcement">Professionalism in the Workplace: Integrity in Enforcement</a>.



Their authorities are explained in the Role and duties of Alberta OHS officers.

# Right to confidentiality and privacy

OHS only uses personal information for the purpose for which it was obtained, unless disclosure is required or permitted under the *Freedom of Information and Protection of Privacy Act*, or as required by other law.

### Right to appeal an OHS action

If you receive an order from OHS or disagree with certain OHS decisions, you can appeal the matter to the Alberta Labour Relations Board (ALRB).

The ALRB hears appeals of OHS orders, administrative penalties, licence cancellations or suspensions, work refusal investigations and disciplinary action complaint decisions.

The ALRB can:

- Confirm, vary or revoke an order, or certain decisions or actions.
- Remit orders, or certain decisions or actions back to OHS.
- Reject hearing an appeal if the ALRB determines it is without merit, or is frivolous, trivial, vexatious, filed without merit or an abuse of process.
